CREATE WILL ALSO COLLECT AND USE HEALTH INFORMATION PROTECTED BY HIPAA IN ACCORDANCE WITH ALL HIPAA REQUIREMENTS.

Create will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Create or the site; (b) protect and defend the rights or property of Create; and, (c) act under exigent circumstances to protect the personal safety of users of Create, or the public.

Use of Cookies

The Create web portal use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you



time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Create pages, or register with Create site or services, a cookie helps Create to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. - Web Beacons. We may tie this information to personal information about you that we collect from other sources or you provide to us.

Third-Party Use of Cookies and Other Tracking Technologies

These third parties may use cookies [alone or in conjunction with web beacons or other tracking technologies] to collect information about you when you use our web portal or mobile app. The information they collect may be associated with your personal information or they may collect information, including personal information, about your online activities over time and across different websites and other online services. They may use this information to provide you with interest-based (behavioral) advertising or other targeted content.

We do not control these third parties' tracking technologies or how they may be used. If you have any questions about an advertisement or other targeted content, you should contact the responsible provider directly.

Disclosure of Your Information

We may disclose aggregated information about our users and information that does not



identify you or any individual without restriction. Such aggregated information shall be deidentified in accordance with the requirements of HIPAA.

WE MAY DISCLOSE PERSONAL INFORMATION THAT WE COLLECT OR YOU PROVIDE AS DESCRIBED IN THIS PRIVACY POLICY:

- To our subsidiaries and affiliates in order to provide services to you and your health plan.
- To contractors, service providers, and other third parties we use to provide services to you and your health plan and to support our business and who are bound by contractual obligations to keep personal information confidential and use it only for the purposes for which we disclose it to them.
- To fulfill the purpose for which you provide it.

WE MAY ALSO DISCLOSE YOUR PERSONAL INFORMATION:

- To comply with any court order, law, or legal process, including responding to any government or regulatory request.
- To enforce or apply our Terms and Conditions of Use and other agreements, including for billing and collection purposes.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Create, our clients, members, users, customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.
- Create does not disclose your personal information for marketing purposes.

Choices About How We Use and Disclose Your Information

We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information:

Tracking Technologies and Advertising. You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. To learn how you can manage your Flash cookie settings, visit the Flash player settings page on Adobe's website. If you disable or refuse cookies, please note that some parts of this site may then be inaccessible or not function properly. This does not apply to the mobile app since cookies are not utilized in the app.

Accessing and Correcting Your Information

During open enrollment, you can review and change your personal information by logging into the web portal or mobile app. Certain changes to your information that would impact coverage selections and benefits must be coordinated through Create and in some cases

Security of your Personal Information

Create secures your personal information from unauthorized access, use or disclosure. Create secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information (such as a credit card number or personally identifiable health related information) is transmitted to other websites or portals, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.

Create will maintain your protected health information ("PHI") secure and confidential according to federal and state requirements. Create has the following systems, policies and procedures in place:

- Verification of callers
- Strong passwords required within the electronic system
- Passwords are changed frequently
- PHI is stored in a locked environment
- Sensitive information in transit is encrypted or transmitted via SS.
